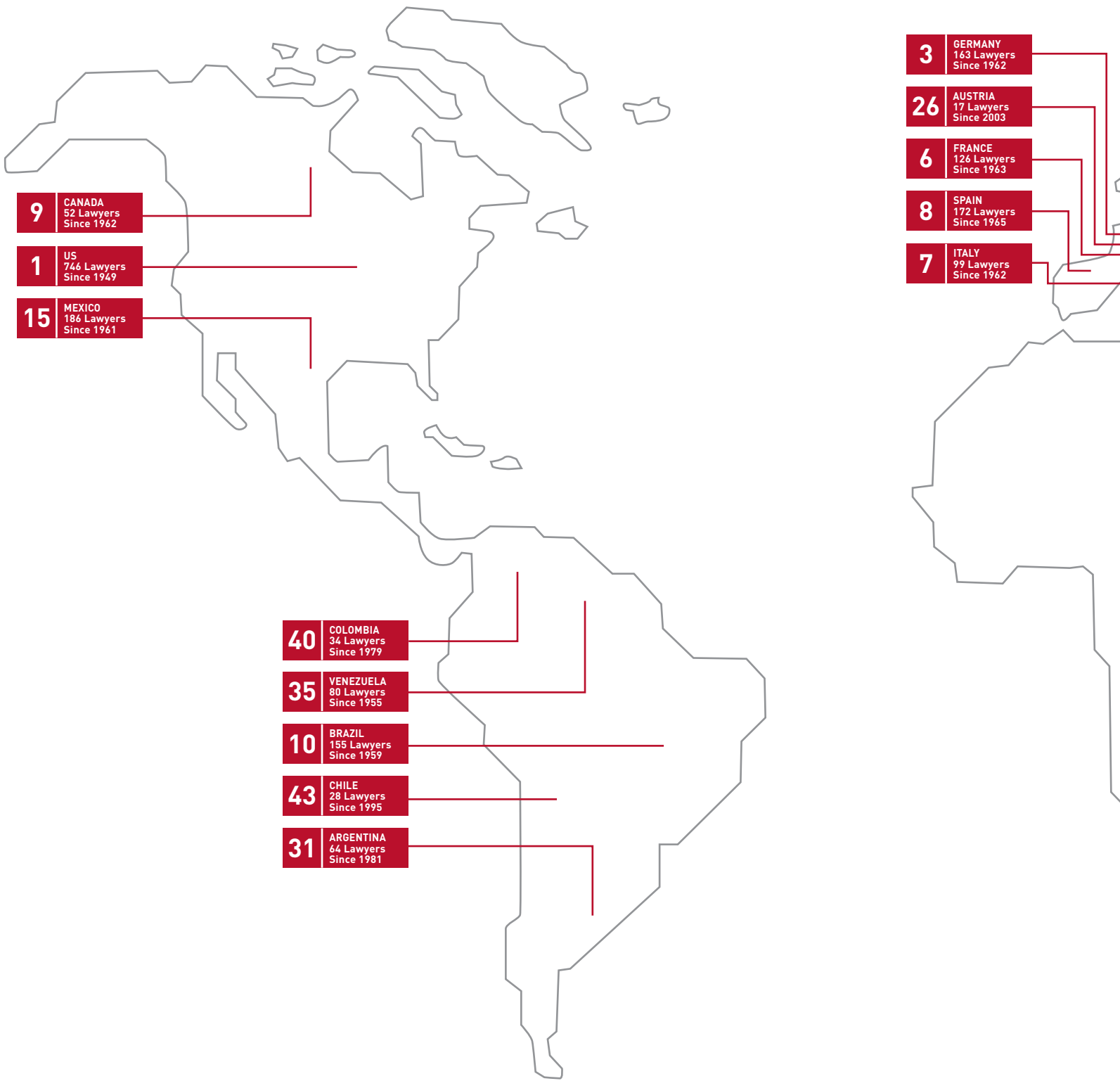

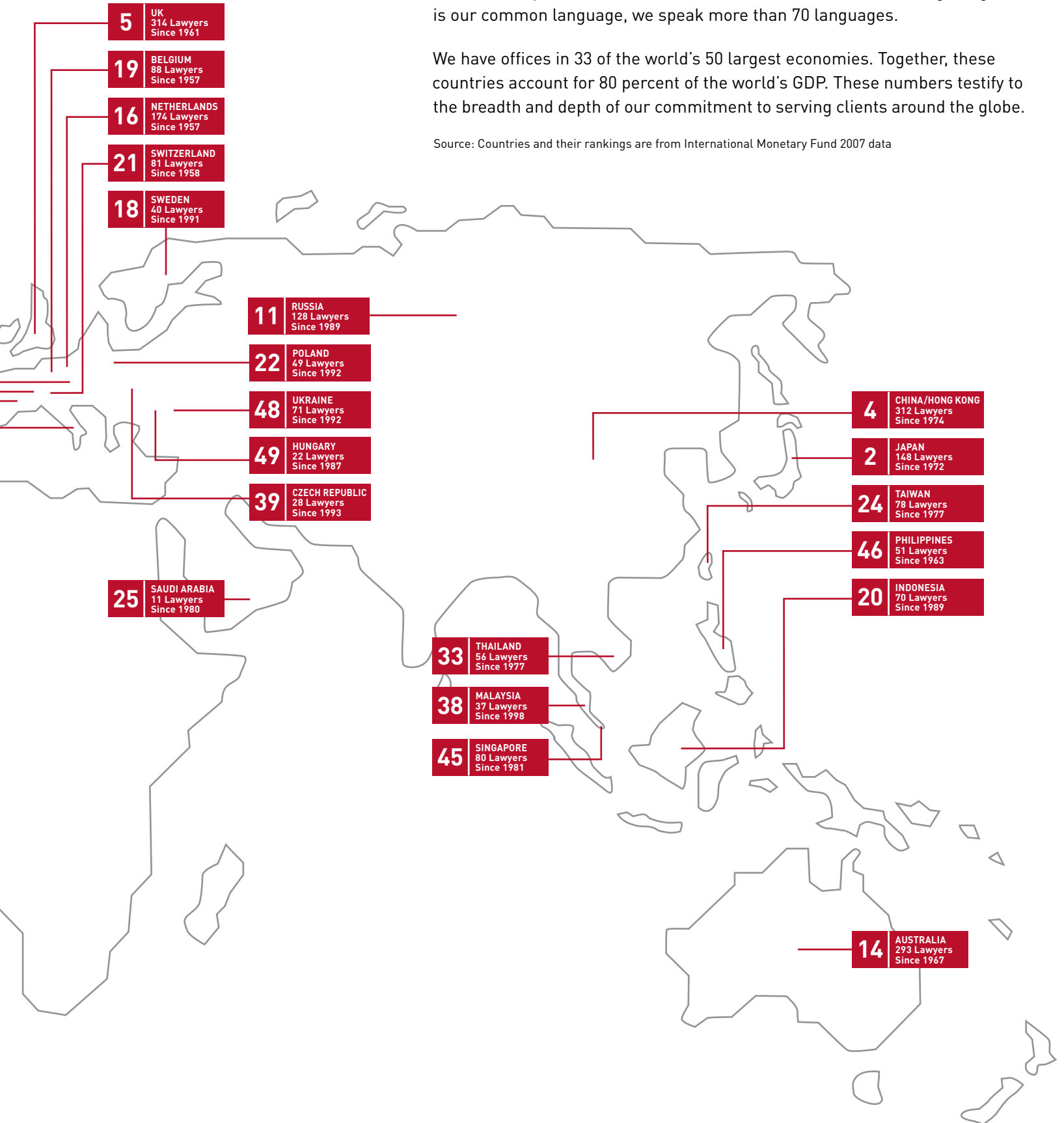


Our Presence in the World's 50 Largest Economies
